\*\*Important note about collecting sales taxes:

FOR SCARE-A-CON at Turning Stone Casino only - Pursuant to an agreement between the Oneida Indian Nation and the State of New York, vendors that sell goods or services at SCARE-A-CON must be authorized by the Oneida Indian Nation Department of Taxation to collect and remit, and must collect and remit, Oneida Indian Nation sales tax on such sales in accordance with the rules of the Oneida Indian Nation Department of Taxation. To obtain the necessary authorization, vendors must file an application for a Certificate of Authority from the Oneida Indian Nation Department of Taxation at least five (5) days prior to the event. As a result of this agreement, vendors who sell goods or services on Oneida Indian Nation lands are not required to collect or remit sales or use taxes to the State of New York.
